ORDER

- [1] **CONSIDERING THAT** the Debtors / Petitioners have filed a *Motion for the Extension of Delays and Renewal of the Initial Order* under Sections 11(4) and 11(6) of the *Companies' Creditors Arrangement Act*, R.S.C. (1985), CH. C-36, as amended (the "CCAA") and sections 2, 20, 33 and 46 of the *Code of Civil Procedure* (the "**Motion**");
- [2] **SEEING** the allegations of the Motion;

- [3] **SEEING** the affidavit of Mr. Ian G. Wetherly;
- [4] **SEEING** the representations of the Debtors / Petitioners and Mises en cause's counsel at the hearing;
- [5] **SEEING** that the Motion is well founded;
- [6] **FOR THESE REASONS, THE COURT:**
- [7] **GRANTS** the Motion *for the Extension of Delays and Renewal of the Initial Order*;
- [8] **EXEMPTS** the Debtors / Petitioners from the obligation of serving the *Motion for the extension of Delays and Renewal of the Initial Order*, and any affidavit, any notice of presentation and any exhibit, upon any party who did not file an appearance or advise the Debtors/Petitioners' counsel or the Monitor, and who did not file said appearance in the court record;
- [9] **EXTENDS** the Stay Termination Date (being October 7, 2008, as defined in the Initial Order rendered on June 26, 2008 by the Honourable Chantal Corriveau, J.C.S. and as extended by the Hon. Joël A. Silcoff, J.C.S. on July 26, 2008), for a period of one hundred twenty (120) days, being until and including February 4, 2009;
- [10] **RENEWS** the Initial Order rendered on June 26, 2008 by the Honourable Chantal Corriveau, J.S.C. in the present file, in its entirety, but with the necessary adaptations, if need be, and with the amendments made and the extension granted by the Hon. Joël A. Silcoff, J.C.S. on July 26, 2008 to be valid until October 7, 2008, for an additional period of one hundred twenty (120) days, being until and including February 4, 2009;
- [11] **ORDERS** the provisional execution of this Order, notwithstanding any appeal;
- [12] **THE WHOLE** without costs, unless this order is contested.
